### SELECTED NOTES AS PER GFGC CONSTITUTION

#### 14. ELECTION OF THE COMMITTEE

- (1) Each nomination for election to the Committee shall be in writing and be signed by two Members eligible to vote and by the nominee, and shall be in the hands of the Secretary at least seven days before the Annual General Meeting. Notification of the receipt of each nomination shall be placed on the notice board. Only Members and Life Members shall be eligible for election to the Committee.
- (2) A nomination, once properly made in accordance with the rules, may be withdrawn only if the withdrawal is approved by at least two thirds of the Members personally present at the Annual General Meeting and eligible to vote, including the proposer, the seconder and nominee.
- (3) A Member may be nominated for any one of the offices (a) to (h) in rule 13(2) and in addition for the office of Committeeman/Committeewoman. Should the Member not be elected to the office (a) to (h) of rule 13(2) for which he or she has been nominated, his or her nomination for the office of Committee member shall be valid. Should the Member be elected to the office (a) to (h) of rule 13(2) for which he or she has been nominated, his or her nomination for the office of Committee member shall lapse. No Member shall be elected to more than one office at an Annual General Meeting.
- (4) At the Annual General Meeting the election of officers shall be dealt with in the order of their listing in rule 13(2). The elections for the offices (a) to (h) of that rule shall be completed before proceeding to the election for the office of Committee member.
- (5) If the number of nominations for any office is less than the number of vacancies in that office, or is equal to the number of vacancies in that office, the chairman of the meeting shall declare the nominees duly elected.
- (6) If the number of nominations for any office is greater than the number of vacancies in that office, an election shall be held by secret ballot.
